FREE LEGAL LITERACY AND LEGAL AID CAMP THROUGH FREE LEGAL AID CLINIC

Narayanrao Chavan Law College, Nanded runs a free legal aid clinic approved by Bombay High Court. College in collaboration of District legal Services Authority, Nanded and independently as well carries out several activities towards its commitment for providing free legal literacy and free legal aid through Free legal Aid clinic.

This year college has remarkably organized, conducted and participated in various activities involving legal Aid. The details are provided below

1. A program on Legal Literacy and awareness has been organized at college campus on 12th August 2022, for spreading legal awareness about consumer rights. Smt. Anuradha Satpute Lokhande, President, District Consumer Dispute Redressal Commission, Nanded has provided the awareness on the topic Jago Grahak Jago.
2. College has organized Legal Literacy Camp at the college premises, on 27th September 2022, in collaboration with DLSA, Nanded. Wherein Secretary DLSA Smt. D. M. Judge called as a resource person, she has enlightened the students about POCSO. Other resource person's were Adv. Ram Kanote, who has provided Legal literacy on various activities and financial aids provided by the Government. Adv. Nayyum Khan Pathan expressed his views on the requirement of Legal Aid to the poor litigants.
3. Organized Legal Literacy camp at the college premises on 10th November 2022, in collaboration with DLSA, Nanded. Under the Banner of "Hakk hamara bhi to hai @ 75" campaign launched by NALSA, New Delhi. Wherein Shri. A. B. Jadhav, JMFC and CJJD, District Court Nanded has provided the students information about the requirements of providing free legal aid to the poor and deprived class and the objectives of the scheme.
4. Organized Legal Literacy camp at the college premises on 11th November 2022, in collaboration with DLSA, Nanded. Under the Banner of "Hakk hamara bhi to hai @ 75" campaign launched by NALSA, New Delhi. Wherein Shri. S. L. Yeldi, JMFC and CJJD, District Court Nanded has provided the students information about the Fundamental Duties enshrined under the Indian Constitution and need to follow the fundamental duties to let the general public enjoy their Fundamental Rights.
5. Students of college, who are recognized Para Legal Volunteers have interacted with 484 prisoners and 1 child in conflict with law.
6. Students of college has participated in Door to Door campaigning program organized by DLSA, Nanded under the Banner of Hakk Hamara bhi to hai @ 75. The campaign went on from 31.10.2022 to 13.11.2022. In all 300 students of our college took part in various activities organized by DLSA and Door to Door campaigning. Students visited more than 70000 persons during this campaign. Principal District Judge Shri. N. B. Nhavkar have specially appreciated the college by awarding a letter of appreciation. Dr. S. B. Kadam acted as coordinator for this campaigning.
7. Students performed Street play during legal Literacy camp organized by DLSA, Nanded at the campus of Peoples College, Nanded on 13th November 2022.
8. 20 Students of college acted as volunteers in National Lokadalat for 2 times.
9. A free legal Aid camp has been organized at the campus of college on 16th December



2022, on the topic UDHR @ 75, Principal District Judge shri Nagesh Nhavkar guided the students about the role of UDHR in human Development through protection of Human Rights. Secretary, DLSA Smt. Daljeet Kaur Judge has also enlightened the students on Free legal aid towards fulfilment of UDHR. The program also witnessed distribution of certificate of appreciation to the students for their participation in various activities by Free Legal Aid clinic.

10. A legal aid and Legal Literacy camp is organized at the campus of Rajiv Gandhi college, Mudkhed on 7th February 2023, towards the commitment of college for adopted taluka. The camp has been organized under the caption “ Know your Rights @ 75”. In all 40 students of college took part into this camp. Shri S. B. Dhembre, CJJD & JMFC, Mudkhed also attended the camp and enlightened the students about requirement of free legal aid into the life of unrepresented litigants.

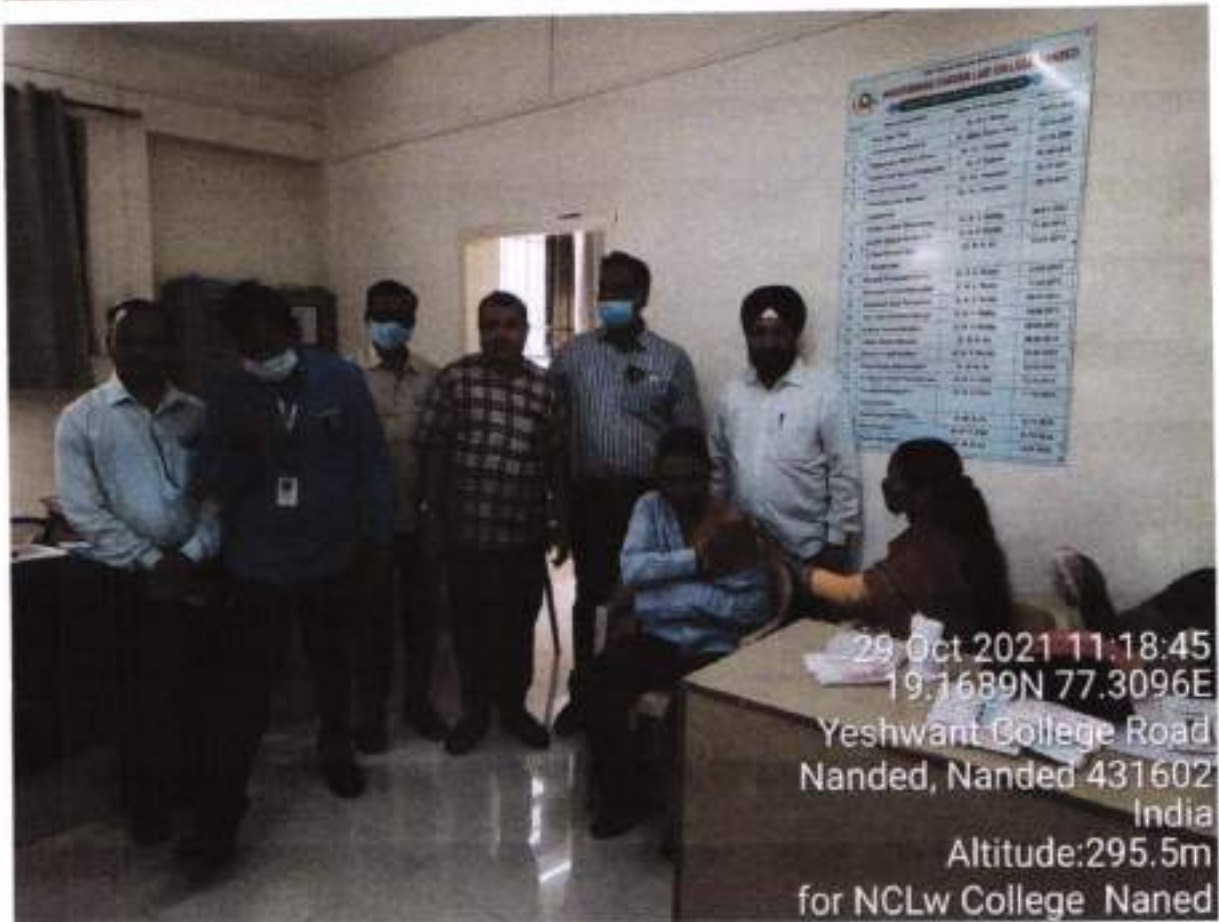

Report on Quiz Competition

On 3rd November 2018, a Quiz competition on "Laws related to Women" was conducted in college in association with National Commission for Women. A notification was published by National Commission for Women, on 24th August 2018 regarding Nation-Wide Competition for college/university students. The objective of said competition was to generate awareness about legal rights of women & to ensure that all sections of society are fully conversant with the law and contribute effectively for their successful implementation. Also, a letter was received by the college from Joint Director, Higher Education, Nanded regarding said competition.

As per National Commission for Women Notification, the colleges were required to get themselves registered on the Online Portal of National Commission for Women and shall have to organize competition on any dates between 1st September 2018 to 31st December 2018. Accordingly, Dr P V Bandewar was appointed as Coordinator for the Quiz Competition and directed to do the needful. On 22nd October 2018, college is registered on Online Portal of National Commission for Women and login account of college is created.

For conducting the Quiz competition successfully, various committees like Administrative Committee, Paper setting Committee, Invigilators, Paper Evaluation Committee etc. were constituted. A notice was displayed on Notice Board and students were directed to register their name on or before 31st October 2018. The rules and syllabus for said Competition were also displayed on Notice Board. A notice was circulated among faculty members regarding the Competition. As a result, total 129 students registered their name for Competition. As per the guideline of Notification, the Paper Setting Committee prepared question paper comprising 100 Multiple Choice Questions of one mark each. Total 135 question paper set were printed out for conducting Quiz Competition.

On 3rd November 2018, Competition was conducted between 10.00am to 11.30am. Participating students have been given seat numbers and the same were displayed on Notice Board for their reference. Twenty-six students were accommodated in each class. Out of 129 registered students, 104 students appeared for the Competition. Five invigilators were appointed for five class rooms (one invigilator for each class). After conducting Quiz competition, the papers were assessed by Paper Assessment Committee members. Thereafter, the result was prepared and same was displayed on Notice Board. The answer key was also displayed on Notice Board. Following are the winners of said competition-
