With an intention to familiarize the newly admitted students with various facilities and amenities available in the college, the Internal Quality Assurance Cell (IQAC) organized Students Orientation Programme-2018. The programme was scheduled on 28th September 2018. The Programme began with gathering of all the students of B.A. LL.B. I year and LL.B. I year in Moot Court Hall at 11:15 AM. 


