REPORT ON NEW STUDENTS ORIENTATION & CAMPUS TOUR (LLB I & B.A. LL.B. I YEAR)

With an intention to familiarize the newly admitted students with various facilities and amenities available in the college, the Internal Quality Assurance Cell (IQAC) organized Students Orientation Programme- 2018. The programme was scheduled on 28th September 2018. The Programme began with gathering of all the students of B.A. LL.B. I year and LL.B. I year in Moot Court Hall at 11:15 AM. The students were given a short briefing about IQAC and purpose behind organizing this orientation. Minutes of the meeting

The meeting of the Discipline Committee was held in the Principal's room under the chairmanship of Dr. Vikash Kakhare on dated 11/02/2020 on Wednesday at 10.30am. One of the agenda items was to take action against Md. Shadab Md. Fejaj, a student of B.A. LL.B. 1st year of the College. The student had misbehaved in Hall No. 1, breaking the glass of one window, threatening others in the class, and, despite many warnings in the past, continued this behavior.

The committee has sought a written explanation from the student as to why disciplinary action should not be taken against him. The disciplinary committee, along with the student's parents, have requested a written explanation from the student. On 11/02/20, the committee unanimously decided as follows:

- A penalty of Rs. 2000/- for the mischief done, and the student must pay for the damage and repair it in the school.
- The student will be suspended for the rest of the semester and only allowed to appear for the examination.
- Any such misbehavior will not be tolerated in the college in the future.
