College in collaboration of District legal Services Authority, Nanded and independently as well carries out several activities towards its commitment for providing free legal literacy and free legal aid through Free legal Aid clinic.

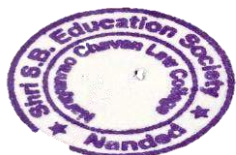
This year college has remarkably organized, conducted and participated in various activities involving legal Aid. The details are provided below

1. A program on Legal Literacy and awareness has been organized at college campus on 12<sup>th</sup> August 2022, for spreading legal awareness about consumer rights. Smt. Anuradha Satpute Lokhande, President, District Consumer Dispute Redressal Commission, Nanded has provided the awareness on the topic Jago Grahak Jago.
2. College has organized Legal Literacy Camp at the college premises, on 27<sup>th</sup> September 2022, in collaboration with DLSA, Nanded. Wherein Secretary DLSA Smt. D. M. Judge called as a resource person, she has enlightened the students about POCSO. Other resource person's were Adv. Ram Kanote, who has provided Legal literacy on various activities and financial aids provided by the Government. Adv. Nayyum Khan Pathan expressed his views on the requirement of Legal Aid to the poor litigants.
3. Organized Legal Literacy camp at the college premises on 10<sup>th</sup> November 2022, in collaboration with DLSA, Nanded. Under the Banner of "Hakk hamara bhi to hai @ 75" campaign launched by NALSA, New Delhi. Wherein Shri. A. B. Jadhav, JMFC and CJJD, District Court Nanded has provided the students information about the requirements of providing free legal aid to the poor and deprived class and the objectives of the scheme.
4. Organized Legal Literacy camp at the college premises on 11<sup>th</sup> November 2022, in collaboration with DLSA, Nanded. Under the Banner of "Hakk hamara bhi to hai @ 75" campaign launched by NALSA, New Delhi. Wherein Shri. S. L. Yeldi, JMFC and CJJD, District Court Nanded has provided the students information about the Fundamental Duties enshrined under the Indian Constitution and need to follow the fundamental duties to let the general public enjoy their Fundamental Rights.
5. Students of college, who are recognized Para Legal Volunteers have interacted with 484 prisoners and 1 child in conflict with law.
6. Students of college has participated in Door to Door campaigning program organized by DLSA, Nanded under the Banner of Hakk Hamara bhi to hai @ 75. The campaign went on from 31.10.2022 to 13.11.2022. In all 300 students of our college took part in various activities organized by DLSA and Door to Door campaigning. Students visited more than 70000 persons during this campaign. Principal District Judge Shri. N. B. Nhavkar have specially appreciated the college by awarding a letter of appreciation. Dr. S. B. Kadam acted as coordinator for this campaigning.
7. Students performed Street play during legal Literacy camp organized by DLSA, Nanded at the campus of Peoples College, Nanded on 13<sup>th</sup> November 2022.
8. 20 Students of college acted as volunteers in National Lokadalat for 2 times.
9. A free legal Aid camp has been organized at the campus of college on 16<sup>th</sup> December



2022, on the topic UDHR @ 75, Principal District Judge shri Nagesh Nhavkar guided the students about the role of UDHR in human Development through protection of Human Rights. Secretary, DLSA Smt. Daljeet Kaur Judge has also enlightened the students on Free legal aid towards fulfilment of UDHR. The program also witnessed distribution of certificate of appreciation to the students for their participation in various activities by Free Legal Aid clinic.

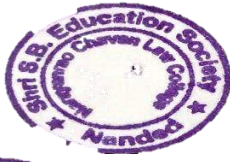

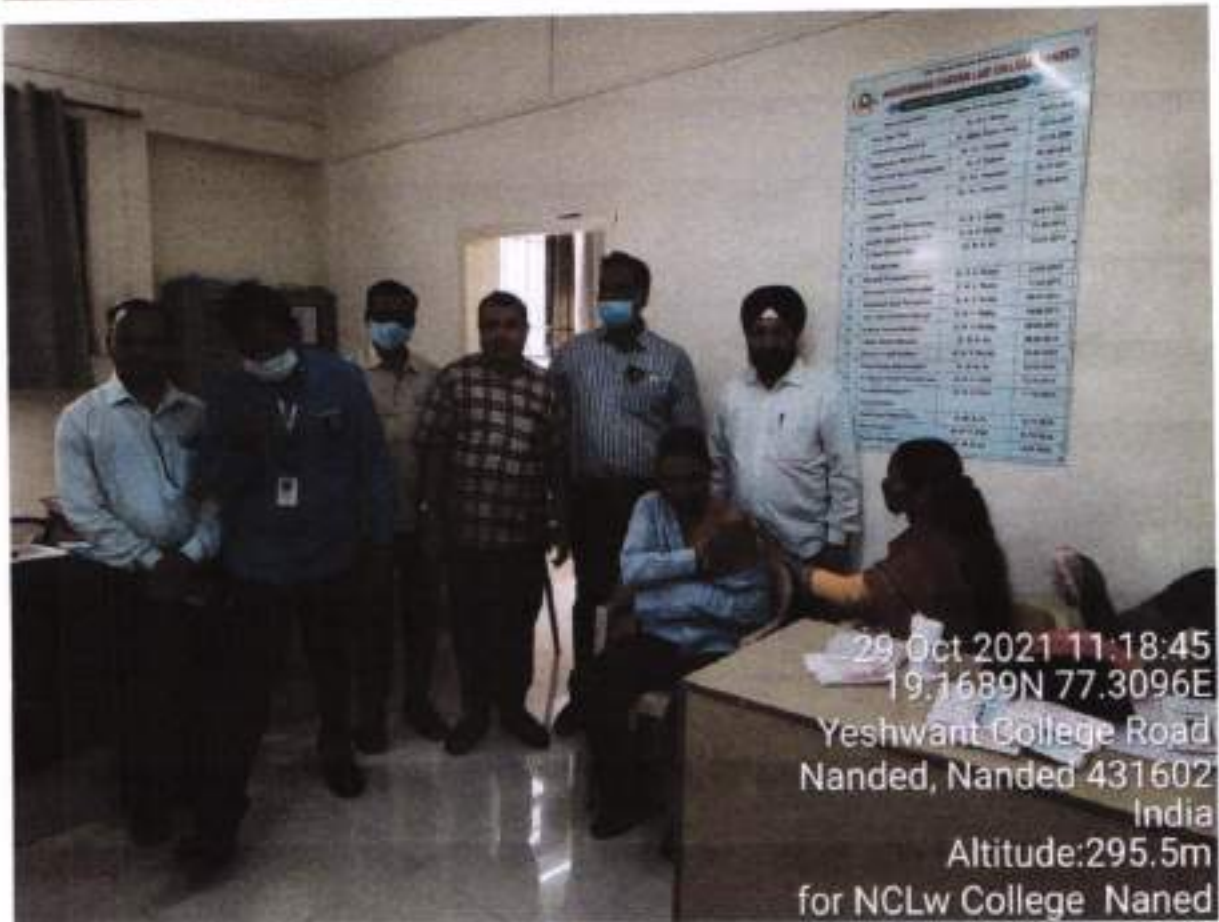
## **Covid-19 vaccination camp concluded at Narayanarao Chavan Law College, Nanded**

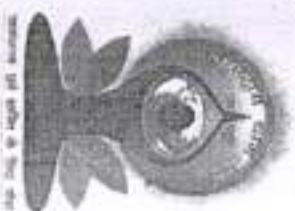

## INTRODUCTION

It is said that 'Delay Justice is Justice Denied', on the basis of this principle and to regain the faith of the people on justice system with speedy disposal of cases, the judiciary has engaged mechanism of Alternative Dispute Resolution (ADR) system and Lok-Adalat is a one of the part of the Alternative Dispute Resolution in India. India has been fortunate enough to have a Justice like JJ. Bhagwati P.N. who was the chief justice of India and he promoted the concept of Lok Adalat. Lok-Adalat is a combination of two words 'Lok' and 'Adalat', Lok means people and Adalat is a 'Court'. It is taken together as a 'People's Court' or 'Jana Nyayalay'. Lok-Adalats are organised to promote justice on the basis of equal opportunity and not to deny that justice to any citizen by reason of the economic or other disabilities. The Lok-Adalat has been given legal status by enacting the Legal Service Authority Act, 1987.

Lok Adalat is a non adversarial method of dispute resolution; it means there is no contest between the disputed parties. It is a system where the both parties are brought together through mediation, conciliation and any other persuasive modes to settle the dispute by amicable way. Lok Adalats are held by the authorities right from top to bottom which are the Supreme Court Legal Services Committee, High Court Legal Services Committee, District Authority and Taluka Legal Services Committee.

The services provided by the Lok Adalat are free of cost to litigants. In fact, Lok Adalat panel consists of the three members, an acting judge or a retired judge, an advocate and a social worker. Through this proceeding, they work as a conciliator and mediator and try to resolve disputes peacefully. Two types of the matters are brought to the Lok-Adalat, first is pre-litigation and other post-litigation cases. Pre-litigation cases are settled by the panel in open premises of the court and the post-litigation cases/pending cases are settled in the respective court building. The cases to be decided by Lok Adalat are various types like criminal compoundable cases, traffic challan cases, matrimonial disputes, land disputes, cheque bouncing cases, loan recovery by banks, telecom bill recovery cases etc. The award given by the Lok-Adalat has binding force upon the disputed party. No further appeal is allowed to the upper court against the award given by the Lok Adalat. Most importantly, every award of Lok Adalat is equivalent to the decree passed by the regular civil court.

## OBJECT OF THE VISIT TO NATIONAL LOK-ADALAT AND DISTRICT LEGAL SERVICES AUTHORITY, NANDED

It is essential in the curriculum by Bar Council of India and S.R.T.M University, Nanded for law students to observe the proceeding of the Lok Adalat as a part of internship and training, and of course, the purpose behind visiting to Lok Adalat and District Legal Aid Services was to understand the working of the same and nature of duties of the judicial officers in the matters of Lok Adalat. It was also intended to understand the mechanism of conciliation and mediation. To make students understand how Lok Adalat is different from regular court in terms of working and now it has settled as an alternative dispute resolution.

### PREPARATIONS BEFORE THE VISIT

A Lok-Adalat visit was organised by Narayanrao Chavan Law College, Nanded and which was scheduled to take place on 11th December, 2021 by District Legal Services Authority, Nanded. In order to inform to the interested students about the visit, the college authority had published a notice on the official Telegram group of the BALLB-IV year and LLB-II year students on 2nd December, 2021 containing all instructions of the safety measures and precautions to be taken by the students related with Covid-19 and suddenly broke out of its new variant Omicron virus. Moreover, the students were informed to present in the college one day before the visit on 10 December 2021 at 11 a.m. for reminding and briefing as to the event.

On 11 December 2021 the students were gathered wearing a white uniform at the premises of the college in order to visit National Lok-Adalat at 9:00 a.m. Forty four students were registered for this event. The attendance of all the students have been registered before proceeding to Lok-Adalat and making sure they are fully vaccinated, 38 out of the 44 students were found fully vaccinated and remaining six students were partially jabbed. They could not be accommodated in the visiting group as they were partially vaccinated. Therefore, they have been asked to abstain from this event. The students have strictly followed Covid-19 norms while they were in the college and court premises. The students were taken to District Court, Nanded after 10:00 am from the college for a visit.

### OBSERVATION OF THE LOK ADALAT PANEL

It was an occasion on the 11th December, 2021 to witness a session of the National Lok Adalat, Nanded. The students of Narayanrao Chavan Law College, Nanded under the guidance of Dr. Narwade S.S. and Dr. S.B. Kadam was visited to District Court, Nanded on 11 December 2021 with the objective of gaining practical knowledge and deep understanding of working of the Lok Adalat in real sense.

As before leaving the college to Lok Adalat, the students were divided into the seven groups as per the panel number. As an enthusiastic group of students entered the premises of the court, the Secretary of District Legal Services Authority, Nanded, Shri. R.S. Rote has briefed upon the infrastructural aspects of the Lok Adalat and its set up. He said that sessions of the Lok Adalat are held on the 2nd and 4th Saturday of the month. Further, he made an introduction of the Lok-Adalat panels to students in the parking area of court premises which has been set up by make-shift tents. He told the student that the panels have been divided into two categories, pre-litigation and post-litigation matters. Mostly, in the pre-litigation stage, Banking, BSNL billing cases and traffic challan cases are referred. He told the student that each panel consists of three members, an acting judge or retired judge, an advocate and a social worker and there are 12 panels in Lok Adalat. Panel no.1 in hall no. 2 was presided over by District Judge-3 Shri. S.E.Bangar and two other members and cases referred by them were motor accident and compensation. Panel no.2 in hall no. 6 was chaired by Shri S.B Dige, District Judge-2. They were having matters of electricity and matrimonial disputes. Panel sr. no. 1, to 7 were to decide post-litigation matters and panel sr. no. 8 to 12 were specially arranged for pre-litigation cases. On this occasion the faculty members of Narayanrao Chavan Law College, Nanded were also present Principal Dr. Vikas

Khakre, Prof. Dr. M.B. Ali, Prof. Dr. Charanjitsingh Mahajan, Dr. A.B. Karwa and Dr. Mahesh Patil. They had dialogues with senior authority of the DLSA and members Bar Association of Nanded.

A group of the students had allotted a separate panel each for observation. Each group of the students had an interaction with the panel judges and the panel has provided all information related with the matter to the students. The students collected the information of the settled cases and they also asked questions to the panellist and they answered the questions in a friendly manner. The authority of DLSA, Nanded also highlighted that the success rate form on alternative dispute resolution mechanism has achieved in the past years. He mentioned that the dedication among legal stakeholders is so much that they have successfully arranged National Lok Adalat. At the end of session of the National Lok-Adalat, the Secretary of DLSA, Nanded gave the information of settled cases. He said, in category post-litigation matter, 206 cases were disposed of, in pre-litigation category 131 cases were settled and 19303 traffic challan cases were disposed of.

### CONCLUSION

At the end of the session of National Lok-Adalat, it was a great learning experience for the law students. The proceedings of Lok Adalat were inclusive. There is no need of representation by lawyer for participating in Lok-Adalat proceedings. It is a direct participation of litigants with consent of both parties without a legal environment. Lok-Adalat has a great importance as it helps to settle the matter amicably and quickly but it does not mean that it is an alternative to regular courts. In sum, it can be said that awareness and literacy about Lok-Adalat and such efforts should be given a priority over regular legal matters by the legal fraternity. For progressive society, it is necessary to save time and resources of the state and it is best to ensure that all citizens are aware of the judicial remedies available by Lok Adalat and this convenient dispute resolution mechanism should be given a preference for swiftly disposal of cases.

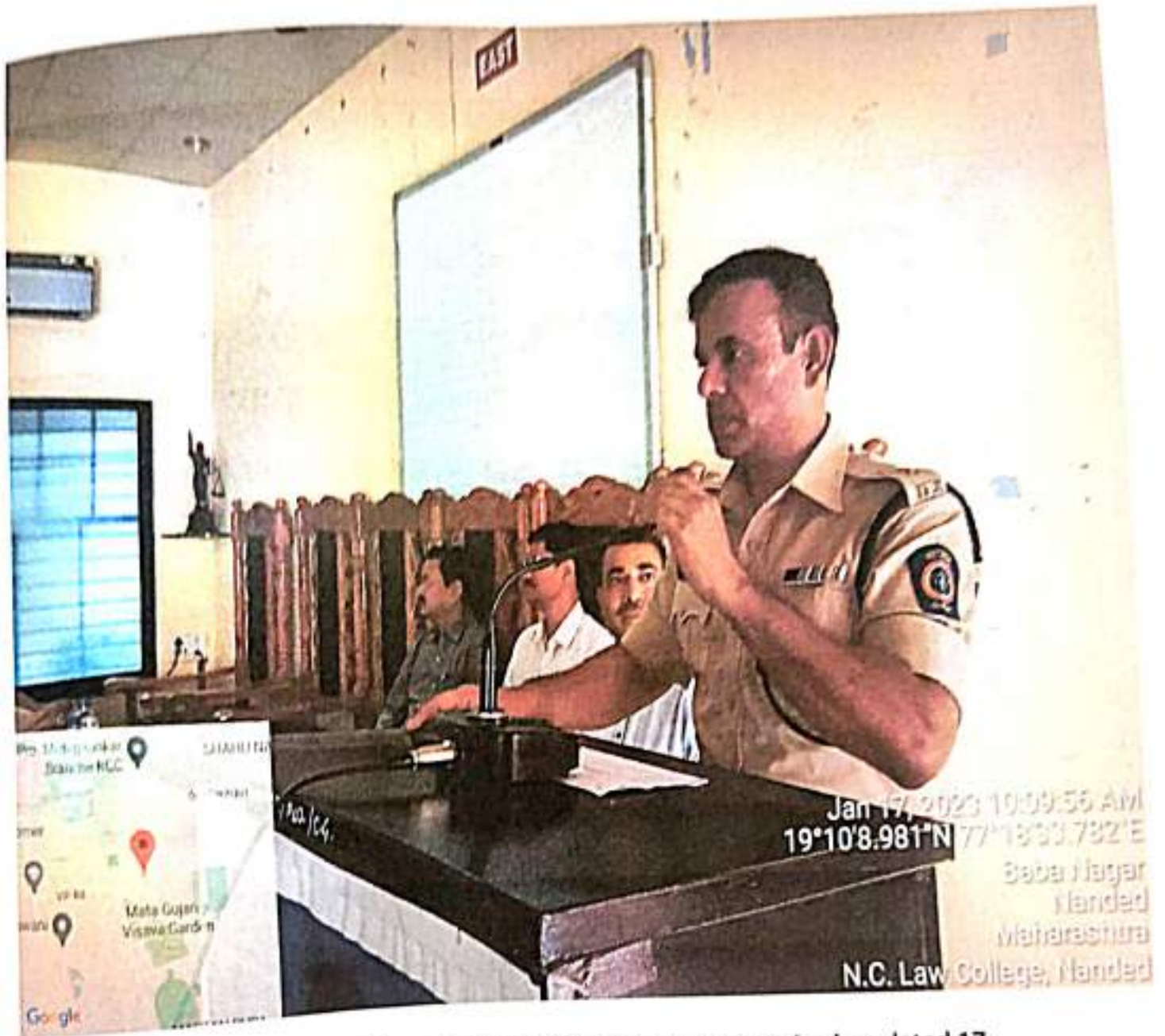
The participants were asked to submit their essay within the time period. Within the time limit college has received 23 entries from all over class. The result of above mentioned competition is as follows.
