ANNEXURE – II

MOOT COURT COMPETITION

For 38 years college has organized State Level Moot Court Competition. The moot problem kept for the purpose of the said competition was based on the theme of "Impact of online game on child safety". The notification for the competition was published on the various law resource websites such as- www.lawoctopus.com, www.advocatekhoj.com, and www.lawmantra.co.in. The notification was sent to all colleges in India, resultantly this year it has received a unprecedented response.
