## 15. Multidisciplinary / interdisciplinary

Narayanrao Chavan Law College in Nanded, is undergoing a significant transformation towards becoming a more holistic and multidisciplinary institution. Here's a breakdown of the key points

1. **Multidisciplinary Approach:** Despite being initially focused on mono-faculty professional education, the institute is expanding its offerings to include a wide range of programs and courses covering various disciplines.
2. **BA LLB Course:** The LL.B. 5-year course integrates humanities subjects like Sociology, Economics, History, Political Science, and English in the first year. The curriculum also includes courses in Political Science, Local Self-Government, History of Courts, and English in subsequent years. Additionally, there are courses in Commerce, such as Insurance Law and Principles of Income Tax.
3. **Postgraduate Diplomas:** The institute offers one-year PG Diplomas in Taxation Law, Cyber Laws, Intellectual Property Law, and Labour Law and Labour Welfare, catering to students from commerce, science, technology, arts, social work, and humanities backgrounds.
4. **LL.M. Programs:** The institute offers two LL.M. programs specializing in Criminal Law and Business Law.
5. **Recognition as Study Center:** Narayanrao Chavan Law College is recognized as a study center for the Master of Library Science (M.Lib) course conducted by Yeshvantrao Chavan Maharashtra Open University, Nasik.
6. **Regulation by Bar Council of India (BCI):** The college operates according to the rules set by the Bar Council of India, which does not allow for multiple entry and exit points in the educational programs.
7. **Research Centre:-** Narayanrao Chavan Law college, nanded is a recognized research centre in Law recognized by Swami Ramanand teerth Marathwada University, Nanded.

#### **16.Academic bank of credits (ABC):**

The institute, being affiliated to Swami Ramanand Teerth Marathwada University, Nanded, is following the policies and guidelines set forth by the university. Here's a summary of the key points:

1. **Digilocker and ABC ID:** The university has mandated that all students create their account on Digilocker and generate their ABC ID. This ABC ID is required for filing examination forms. All students appearing for the Summer 2023 university examinations have created their ABC IDs.
2. **Admission Process:** The Internal Quality Assurance Cell (IQAC) has created the admission form for the academic year 2023-24, which requires students to provide their ABC IDs at the time of admission.
3. **Implementation of Academic Bank of Credits (ABC):** While the institute has implemented the ABC system and students have been assigned ABC IDs, there are currently no scores linked to these IDs. The institute plans to work on making the facility of the Academic Bank of Credit available soon, even though there is no existing policy for credit transfer schemes.
4. **Promotion of SWAYAM Courses:** The institute actively promotes students to take courses on SWAYAM. However, the implementation of the Academic Bank of Credit is pending due to regulations from the Bar Council of India, which does not permit multiple entry and exit points in the educational system.

Overall, the institute is taking steps towards modernizing its academic processes, such as digitization of records and the implementation of the ABC system, in alignment with the policies set by the affiliating university.

#### **17.Skill development:**

It's evident that the institute places a strong emphasis on skill development and practical training to prepare students for the



demands of the industry. Here's a breakdown of the key points:

1. **Industry-Oriented Programs:** All programs offered by the college are designed with the goal of skill development to meet the standards of the growing industry.
2. **Curriculum Structure:** The BA LLB course curriculum integrates subjects like English, Professional Ethics, Alternative Dispute Resolution (ADR) systems, and Drafting Pleading and Conveyancing across different years to develop students' soft skills and practical knowledge.
3. **Postgraduate Diplomas:** The college offers four one-year PG Diploma courses (in Taxation Law, Labour Law, Cyber Law, and Intellectual Property Rights) to further polish students' acquired skills.
4. **Prominent Programs:** The college conducts various programs like Moot Court Competitions, Legal Aid Camps, and certificate programs aimed at enhancing students' skills and practical exposure.
5. **New Certificate Programs:** In the academic year 2022-23, the Internal Quality Assurance Cell (IQAC) introduced few new certificate programs specifically focused on skill development.
6. **Expert Faculty:** The PG Diploma in Taxation Law is taught by the Chartered Accountants, indicating the institute's commitment to providing industry-relevant expertise to its students, besides this the other diploma is being taught by the experts sent by Alumni Association.

4. **Study Centre for M.Lib Course:** Narayanrao Chavan Law College is recognized as a study center for the M.Lib course conducted by YCMOU, Nasik, further emphasizing its commitment to regional language education and support.
5. **Shift to Online Mode During Pandemic:** In response to the pandemic, the college shifted its curriculum and examinations to online mode, ensuring continuity in education despite challenging circumstances.
6. **Curriculum Highlights:** Students are required to complete courses on the History of Courts and Family Law, which include elements of ancient religious history, sources of Hindu Law, Muslim Law, etc., demonstrating a comprehensive approach to legal education.
7. **Integration of Indian Knowledge Systems:** The college showcases its commitment to integrating Indian knowledge systems by using modern tools like Telegram to disseminate legal knowledge. Daily updates include legal terminologies with their meanings in English and Marathi, along with Latin maxims. The college is also prepared to adopt the guidelines provided by the National Education Policy (NEP) for legal institutions.

Overall, Narayanrao Chavan Law College's initiatives reflect its dedication to promoting regional language education, embracing modern technology, and providing a well-rounded legal education in alignment with its mission and the evolving needs of legal education in India.

#### **19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

Narayanrao Chavan Law College Nanded demonstrates a commitment to academic excellence, student support, and community engagement through various initiatives. Here's an overview of the key points:

- 1. Program Outcomes and Monitoring:** The college ensures transparency and accountability by uploading program outcomes, course outcomes, and program-specific outcomes on its website. Teaching faculty are required to submit teaching plans and maintain daily teaching diaries. Daily activities are reported in the Daily Teaching Report (DTR) file.
- 2. Assessment and Review:** Continuous internal assessment is conducted throughout the course, with one credit dedicated to this purpose. At the conclusion of the syllabus, a review meeting is held by the Internal Quality Assurance Cell (IQAC) to evaluate the achievement of outcomes. Student feedback is obtained to monitor course outcomes, and policies are framed based on the results of the end-semester examinations conducted by the affiliating university.
- 3. Remedial Classes:** Special remedial classes are organized for students who join the institution late to help bridge any gaps in their learning.
- 4. Additional Certificate Courses:** Four certificate courses were introduced in the current academic year to provide students with additional learning opportunities beyond what is prescribed by the affiliating university.

Therefore, the college is unable to provide online education as approved by the university or BCI. This suggests that the college does not offer online education due to regulatory constraints from the BCI.
2. **Distance Education Mode for M.Lib Course:** However, the college is recognized as a study center for the M.Lib course of Yeshvantrao Chavan Maharashtra Open University, Nasik, which operates in distance education mode. This seems contradictory to the statement that the college is unable to provide online education.
3. **Pandemic Adaptations:** Due to the pandemic, all courses in the previous academic year were carried out in online education mode. This suggests that the college did indeed adapt to online education during the pandemic, despite regulatory constraints.
4. **Use of Telegram for Online Teaching:** The college adopts Telegram, a free-to-use application, for online teaching and learning. Faculty members use this Information and Communication Technology (ICT) facility to facilitate online education.
5. **Sharing Resources:** Faculty members share resources with students on platforms like Telegram and Google Classroom,

further indicating the use of online tools for education.

6. **Online Assessment Tools:** Online tools such as Google Forms are used to conduct rapid quizzes and online unit tests, indicating further adaptation to online education methods.

In summary, while the college is recognized as a study center for distance education courses and has adapted to online education during the pandemic, there may be regulatory constraints from the Bar Council of India regarding the conduct of online courses. However, the college appears to be utilizing online tools and platforms for teaching, learning, and assessment despite these constraints.

- All teaching and non-teaching staff are placed in their respective scales based on eligibility, with no pending cases.
- For every CAS proposal, the IQAC calculates Academic Performance Indicators (API) and ensures its inclusion before submission to the university.

This performance appraisal system ensures fairness, transparency, and adherence to established guidelines, ultimately promoting career growth and maintaining quality standards within the institution.

OBSTACLES FACED/ PROBLEMS ENCOUNTERED: - Budgetary constraints often hinder the implementation of these activities. Additionally, limited student motivation poses a challenge to their active participation. Moreover, securing suitable locations for conducting the camps proves to be difficult. IMPACT OF PRACTISE/ EVIDENCE OF SUCCESS: - As a result of this practice, the college received an appreciation certificate presented by the Principal District Judge. The Honorable PDJ expressed appreciation during a public event attended by the District Collector, Superintendent of Police, and all judges. Witnessing the enthusiasm of the students engaged in the door-to-door campaign, many other students who were not initially involved also joined as volunteers. RESOURCES REQUIRED: - Organizing these legal aid camps necessitates strong willpower and commitment from students, coordinators, and the institute alike. Additionally, obtaining permission from the venues where the camps are to be conducted is imperative. BEST PRACTISE 2:

THINK GLOBAL ACT LOCAL: PROMOTION OF LOCAL LANGUAGE IN CURRICULUM DELIVERY Legal language has its origin in Latin language, however, gradually it is developed in English. The legal system followed by we people in India, largely devolves from English system, accordingly the laws have been written in English, taught in English and studied in English by the students at large. However, Swami Ramanand Teerth Marathwada University i. e. affiliating university has provided an option to the students of law to write their answers in regional language i. e. Marathi Language. Owing to this facility provided to the students of law, the institute has adopted a mechanism to adopt an inclusive policy with the name "Words of the day" which has started with an object that, the students in all should be able to know the legal terminologies with its Marathi meaning.

THE CONTEXT: Marathwada region, the extreme backward region in Maharashtra state, is industrially under developed. College do not see any campus placement, owing to its cultural, educational, industrial backwardness. Thus, students graduating from this College mostly opts for court room practise, and thus selects lower court i. e. Court of JMFC or District Court as their place of practise. High Court being at a distant place, very few afford to start practise there.

THE OBJECTIVES OF THE PRACTISE: - The institute has its stated vision, mission, goals and objectives as reflected in prospectus, website, citizens charter etc. The vision inter alia states *Judiciam Dei*, which means "Throne of Judgement", The Mission kept in mind always refers to "*Fiat Justitia, ruat coelum*", which means, "Let Justice be done though heaven falls." Thus, to fulfil this mission, the college has adopted a practise which enable the graduates who turn to Bar, are later referred as less experienced with the

legal terminology with its local use. The students graduating with LL.B. degree are referred to not aware with the terminology used in the court. Moreover, the university curriculum does not provide Legal Language as one of the courses into the study. Therefore, the institute have planned to overcome, this defect, by providing an insight into the Marathi course to students of law. So that, by learning law in Marathi they shall develop a temper to study the law in English as well. THE PRACTISE: - As a matter of practise, college has installed a white board at the entry door of college. The white board is fixed at such a place, that every individual who enters the college, gets attracted towards the writing on the white board. The board use to consists of five legal terminology and one Latin maxim with its Marathi meaning every alternate day. The college has bought few books for the purpose of those students, who wanted to read the law books in Marathi, and then in English. Few faculties have prepared their power-point slides of their subjects in dual language i. e. English and Marathi. Also, the mode of interaction in class teaching is in dual language. Intra collegiate moot court competition is started wherein the student participants can opt Marathi language for arguments as mooters in the competition. OBSTACLES FACED/ PROBLEMS ENCOUNTERED: - The faculty faced the problem in translating the laws to local language, understand the basic tenets of law in local language, which were not gone through the faculty themselves as well, however very shortly this defect too was came over by the faculty. IMPACT OF PRACTISE/ EVIDENCE OF SUCCESS: - The result of the practise is that, the students were referring to the words written on white board, getting noted these words on their note book, increase in subscription of Marathi books

were observed. Student, who were slow learners in class has started gradually understanding the concept in English and started getting involved in classroom discussions, did not remain slow learners. Moreover, during pandemic, when students were asked to compulsorily not visit the institute, they were requesting the college authority to adopt a way, so that they can get more knowledge of Latin terminologies, English terminologies. Accordingly, Principal himself has undertaken the task to create a Telegram Public Group which shall be open for all. Since the creation of group, various reading materials, English Legal words, with its Marathi Meaning, Latin Maxim have been shared on daily basis. RESOURCES REQUIRED: - To involve the slow learner into the advance educational process, those students, who belongs to Marathi Medium at their earlier studies, were keeping themselves away from classroom discussions, this way by providing them an aid in understanding the complex legal words, with their simple meaning and in local language, these students started getting interest in the curriculum. The resources, which were required to adopt this practice involves, a legal dictionary with Marathi meaning, a complete book on maxim, Marathi Books in library and a platform to disseminate the information.
